**Subject: Implementation of Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2024 and revised IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020**

1. Department for Promotion of Industry and Internal Trade has issued the **Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2024**. Through the QCO, BIS certification is mandatory for all electrical appliances intended for household, commercial or similar applications with rated voltage not exceeding 250 V single phase alternating current or 415 V three phase alternating current and which do not fall under the scope of any other Quality Control Order issued under the Bureau of Indian Standards Act.
2. As per para (2) of Sl. 1 of the Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2024, the electrical appliances which are already covered under any other QCO are not covered under the scope of Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2024. The list of such electrical appliances is enclosed at **Annexure – I** for information and guidance.
3. All manufacturers of electrical appliances as per the scope of the QCO are required to obtain BIS certification licence as per IS 302 (Part 1) : 2008 as per Scheme -I of BIS (Conformity Assessment) Regulations, 2018.
4. The existing IS 302-1 : 2008 'Safety of household and similar electrical appliances: Part 1 general requirements (Sixth Revision)' has been revised and published as IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020 'Household and Similar Electrical Appliances – Safety Part 1 General Requirements (Seventh Revision)'.  
Both the Indian Standards, i.e. IS 302 (Part 1) : 2008 and IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020 are under concurrent running till **23<sup>rd</sup> February 2026**.

**A. Implementation of QCO**

5. The following has been decided with respect to grant of licence for use of BIS Standard Mark of electrical appliances notified under the Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2024:
6. **For new applicants**
  - a. Till the end of concurrent running period, manufacturers can submit applications for grant of licence as per either IS 302 (Part 1) : 2008 or as per revised IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020;

- b. In case application is submitted as per IS 302 (Part 1) : 2008 and relevant product standard is available in IS 302 (Part 2) series; licence will be granted after compliance to IS 302 (Part 1) : 2008 and the relevant clause of IS 302 (Part 2) of electrical appliance is established. Relevant IS 302 (Part 2) standards for electrical appliances indicated in the illustrative list in the QCO is enclosed at **Annexure – II** for information and guidance only;
- c. In case application is submitted as per IS 302 (Part 1) : 2008 and relevant product standard is not available in IS 302 (Part 2) series; licence will be granted based on the requirements specified in IS 302 (Part 1) : 2008;
- d. In case application is submitted as per IS 302 (Part 1) : 2024 and relevant product standard is available in IS 302 (Part 2) series; licence will be granted after compliance to IS 302 (Part 1) : 2024 and the relevant clause of IS 302 (Part 2) of electrical appliance is established;
- e. In case application is submitted as per IS 302 (Part 1) : 2024 and relevant product standard is not available in IS 302 (Part 2) series; licence will be granted based on the requirements specified in IS 302 (Part 1) : 2024 and the requirements in relevant IEC Standards referred in IS 302 (Part 1) : 2024.

**7. For existing licences**

- a. Manufacturers having their products falling under purview of this QCO and having voluntary licence for electrical appliances as per safety standard in IS 302 (Part 2) series or as per product standard can opt to changeover their existing licence to licence as per IS 302 (Part 1) : 2008;
- b. Alternatively, they can opt to get a separate licence as per IS 302 (Part 1) : 2008;
- c. In both the above scenarios, licence as per IS 302 (Part 1) : 2008 will be granted for same scope as of existing licence without any further testing and inspection.

**8. Product Specific Guidelines:**

- a. Product Manual as per IS 302 (Part 1) : 2008 is available on BIS website;
- b. Product Manual as per IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020 has also been made available on BIS website;
- c. These Product Manuals shall be followed for all electrical appliances covered in the scope of the QCO, except where specific Product Manuals are issued by BIS for specific electrical appliances.

9. Manufacturers taking BIS certification of electrical appliances as per IS 302 (Part 1) : 2008 shall be required to changeover to revised IS 302 (Part 1) : 2024 / IEC 60335-1 : 2020 by the end of concurrent running date.

For the same, manufacturer shall be required to submit test report from third party BIS recognized labs for additional parameters and changes as per revised Indian

Standards for the models are per grouping guidelines issued in the respective product manuals.

#### **B. Revision of IS 302 (Part 1)**

10. The significant changes brought in the Indian Standard through revised IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020 is listed at **Annexure – III** for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Indian Standard.

11. Consequent upon the publication of revised Standard, the existing Product Manual of the Standard has also been revised as PM/IS 302 (Part 1)/IEC 60335-1/3/December 2024. In this revision, changes have been made in the Scope of licence, in grouping guidelines, in Scheme of Inspection and Testing (SIT), in Marking Requirements, and in Possible Tests in a Day.

12. The guidelines for implementation of the revised IS 302 (Part 1) : 2024/IEC 60335-1 : 2020 are given below

#### **13. For existing licences:**

- a. All the BOs shall inform the applicants and licencees of IS 302 (Part 1) in their jurisdiction about implementation of the revised IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020 within a week of issuance of these guidelines;
- b. All Licensees shall implement the revised IS 302 (Part 1) : 2024/IEC 60335-1 : 2020 by the end of concurrent running period. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no Licences are under operation without implementation of the revised IS 302 (Part 1) : 2024/IEC 60335-1 : 2020 after the end of concurrent running period. The status of implementation of the revision of the Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running period;
- c. Licencees has to submit the conformity of the components, wherever applicable, as per Cl. 24 of the IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020 by means of a test certificate from supplier or the test report from third party laboratory;
- d. In order to establish conformity of the product to the revised Standard, licensee shall submit test report from third party BIS recognized labs for modified/ additional test requirements (indicated at **Annexure – III**) specified in the revised IS 302 (Part 1) : 2024/ IEC 60335-1 : 2020;
- e. Verification of implementation of the revised Standard, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee;

- f. If the Licensee fails to complete all actions by the end of concurrent running period, it shall be dealt with as per the prevailing guidelines.

**14. For New Applicants:**

- a. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails as per revised Standard, Licence will not be granted as per old Standard;
- b. Applications which are recorded henceforth may be processed as per old or revised Standard. Processing of Application as per old Standard shall be permitted only upto the end of concurrent running and for such cases, Applicant shall give a declaration that they will implement the revised Standard by end of concurrent running;
- c. After the end of concurrent running period, no Licence shall be granted as per old Standard.

**15. For Change in Scope of Licence:**

- a. For change in scope of licence, the relevant provisions as given above for Applicants shall apply;
- b. However, processing of such applications for change in scope of licence as per old Standard shall be permitted only upto the date of implementation of the revised Standard by the licensee or up to the end of concurrent running period, whichever is earlier.

16. The above guidelines shall come into force with immediate effect.
